

## **Terms and Conditions**

## 40-Hour Applied Behavior Analysis (ABA) Coursework

(For Public and Education Professionals)

These Terms and Conditions ("Terms") govern participation in the 40-Hour ABA Coursework ("Course") offered by Small Steps Learning Difficulties Center. By enrolling in the Course, participants agree to comply with the following Terms:

**Eligibility:** The Course is open to the public and education professionals. Participants must be at least 18 years old. No prior experience in ABA is required; however, participants should have a genuine interest in or currently exposed to working with individuals of determination or in educational/behavioral support fields.

**Course Structure:** This Online Course consists of 40 hours of instructional content delivered online: through lectures, interactive activities, case studies, and assessments. The Course is be delivered online, or partly can be in-person, or hybrid if required and set by the trainer. Attendance and active participation are mandatory to fulfill the course requirements.

**Certification:** Upon successful completion of the full 40 hours and meeting assessment requirements, participants will receive a Certificate of Completion. This certificate is not equivalent to professional board certification (e.g., ABAT/ IBT) but provides the eligibility to obtain credentials through IBAO (International Behavior Analysis Organization) and may be used as part of continuing professional development.

**Fees and Payment:** Full payment of the course fee must be made prior to the start date. Fees are non-refundable except in the cases outlined under Cancellations & Refunds. Payment methods accepted: via payment link provided.

Cancellations & Refunds: If the participant cancels at least 14 days before the course start date, a refund will be issued. No refunds will be provided for cancellations made less than 14 days before the course start date. If the organization cancels or reschedules the Course, participants will be offered either a full refund or a transfer to the next available session.

**Attendance & Conduct:** Participants must attend all sessions to receive a certificate. Any absence may result in incomplete status. Professional conduct and respectful communication are expected at all times. Disruptive behavior may lead to removal from the Course without a refund.







**Assessment Criteria:** To successfully complete the Course, participants must: complete all assigned quizzes, knowledge checks, and activities; participate in group discussions, role-plays, and case study exercises; achieve at least an 80% passing score on the final assessment (written and/or practical). Participants who do not meet these requirements will not receive certification. One (1) opportunity for re-assessment may be provided at the discretion of Small Steps. Failure to pass the re-assessment will result in unsuccessful completion of the Course.

Copyright: All Course materials, presentations, recordings, and handouts are the intellectual property of Small Steps.
